Letter from Steve Hunegs



Visiting Israel this past spring, I saw many examples of determination. One example imprinted in my memory: a school in Tiberias built from scratch in a manner of weeks for hundreds of students from families displaced by Hezbollah rocket fire. We follow in the steps of such resilience.

The Jewish people are experiencing the most severe outbreak of global antisemitism since the Holocaust. From the subtle dismissals to overt harassment, discrimination, and violence, the virus of anti-Jewish bias and bigotry has infected ascendant political ideologies, and their adherents, in the United States and around the world.

While our vigilance increases at home and our hearts remain broken for the victims of the October 7 massacre and the hostages still in Hamas captivity, we find a bottomless well of hope and resilience in the wisdom of our ancestors and in our obligations to each other.

By educating, safeguarding, and advocating for our community, we are in constant pursuit of the adage: "It is not your duty to finish the work, but neither are you at liberty to neglect it" (Ethics of our Sages).

We are pleased to report on our remarkable achievements and growth in 2024. Since it's not noted elsewhere in this report, I'm especially proud that our Education and Advocacy efforts have expanded with the hirings of Dorit Fishman, Sarah Rodriguez, and Meira Besikof, growing our ability to reach new audiences, engage volunteers, manage data, and tell our story.

While this latest wave of antisemitism presents significant challenges to Jewish safety and belonging, you, our community, can feel assured that a dedicated team of professionals works around the clock on your behalf.

As always, I thank our team for their tireless efforts, as well as our officers – led by board president Jacy Grais – board members, volunteers, contributors, and supporters for enabling us to replace darkness, despair, and lies with light, hope, and truth.

Community Safety and Security

With a dramatic increase in the number of antisemitic incidents both locally and nationwide, JCRC works closely with law enforcement and supports community partners in meeting their responsibility to protect their people and property. Working together, our community remains strong and secure.



JCRC's Community Safety & Security Services:

1. Physical Security

Consulting with partner agencies in the Jewish community to make their facilities as safe and secure as possible while remaining warm and welcoming to the community.

2. Training

Hosting organization-specific and community-wide trainings, including:

- * Combatting Active Threats
- * First Aid / Stop the Bleed
- Behavioral Detection
- Cyber Safety

3. Security Patrol and Infrastructure

Procuring and deploying security infrastructure that serves the entire community, including bringing patrol vehicles to Jewish community sites as part of our efforts to foster a welcoming and secure environment.

- 4. **Threat Analysis and Information Sharing** Partnering with law enforcement and others to monitor, analyze, and inform our community of potential threats.
- 5. Local Relationships

Establishing and maintaining close working relationships with dozens of law enforcement agencies and diverse interfaith and community partners.

6. National Network

Working alongside and with support from our national partners at Secure Community Network (SCN), the official safety and security organization for the Jewish community in North America.

7. Grants

Assisting with FEMA's Nonprofit Security Grant Program applications and providing security grants when urgently needed.

JCRC and our community express profound gratitude to the Harvey A. Feldman Charitable Trust for making a major gift to enhance community security (see page 25).

Community Security Patrol Initiative

Thanks to the generosity of community funders, JCRC's newest community safety and security initiative brings patrol vehicles to Jewish community sites as part of our efforts to foster a secure and welcoming environment.

Over the past year, our security patrol has made more than **5,000 unique visits** to Jewish institutions in our region. Our intelligence and investigation services have proved essential, in some cases resulting in arrests.

The vehicles are staffed with licensed private security who conduct patrols, incident response, event security, and other services. Robust support from donations to JCRC allows patrols to be provided free-of-charge to Jewish organizations.

Security Matching

JCRC works with individual institutions, whether holding small events or large communitywide gatherings, to assess security needs and assist in either providing or finding security. If you are holding a community event, and unsure how to assess or navigate security needs, please contact JCRC for assistance.

JCRC In Action

In anticipation of the 2024 Legislative Session, JCRC convened approximately **30 meetings** between state legislators and over **200 Jewish constituents**. We organized these gatherings so community members could share their personal stories of how October 7th and the resulting surge in antisemitism at home has impacted them and their families.

Participating in these meetings was an act of resilience and we were relieved that our appeal to legislators to not make antisemitism worse by following the terrible example set by the Minneapolis City Council was heeded and no anti-Israel resolutions or bills were brought to our State Capitol this past session.


In addition to our efforts with state legislators, for the first time, JCRC actively recruited and trained community members to participate in the caucuses and conventions for both political parties. We look forward to expanding these efforts and building upon our successes in the years to come.











Annual Event

More than **650 JCRC supporters** gathered for the 2024 Annual Event featuring *Times of Israel* Senior Analyst, **Haviv Rettig Gur**, one of our highest recorded annual event attendance and a testament to the words of JCRC President, **Jacy Rubin Grais**, "Many years I have thought



that the JCRC was a well-kept secret in our community. An incredible organization doing very important work, but that not enough people knew about. Over the past eight months, that has changed. I have heard story after

story from members of the community learning about what JCRC has done and feeling its effects personally whether in their workplace or their child's school."


From the podium, **Alex Stewart** shared that "while serving as the Hillel Student President, I was able to lend my voice, my passion, and my energy to a cause that the JCRC champions in our community — combating antisemitism. However, when antisemitism began spiking on campus, the JCRC didn't swoop in and take the reins away from the student leaders. Instead, they laid the groundwork for young people to lead and speak about our own experiences, while offering us their wisdom and guidance."

Lauren Murphy, whose middle school daughter was subjected to death threats because she is Jewish, exclaimed "JCRC has been nothing short of lifesaving for our family. JCRC has given our family the strength to stand up against antisemitism and fight for a safer future."

Finally, **Governor Tim Walz** spoke to the importance of our work by explaining that "people's misunderstanding of what's happening or what has happened in the Middle East is just stunning in many cases. And I think that lack of information, that lack of knowledge and the way people throw around certain terms or seem to try and rewrite history, it's apparent to me that what JCRC ... and so many of the advocates in this room knew was, we have got to educate, especially our young people, about the true story. We have to make sure they know."

Honoring the Past and **Building Resilience**

Power of Place European Summer Institute for Holocaust Educators

In 2024, JCRC brought **23 participants** to Europe, including teachers from Minnesota, South Dakota, Nebraska, Texas, Virginia, and Ohio. The learning unfolded as the group toured historical sites through Poland, Germany and the Czech Republic. Standing where history takes place deepens the understanding of the Holocaust, WWII, and antisemitism. Educators also learned about contemporary Judaism in these communities today, and the culture and traditions that continue to shape the Jewish people.

This experiential learning program, generously supported by the Minnesota Vikings and Allianz, is a deeply impactful and unique opportunity that empowers educators to identify ways to bring their own lived emotions, observations and insights into their classrooms and communities.

Holocaust Education and Remembrance



US Holocaust Memorial Museum Trip

On April 16, the JCRC brought over 180 participants to Washington, DC for our annual visit to the United States Holocaust Memorial Museum. 30 years after this trip began, it continues to be an integral and impactful part of the coursework of many high schools and colleges, as well as ongoing professional development for law enforcement and military.

"Educating students and community members about this history is essential, not just to keep the memories living, but to educate for warning signs so this never happens again. Yom HaShoah Community Commemoration

A vital part of our community's Holocaust remembrance, the Twin Cities annual Yom HaShoah Commemoration was hosted at **Bet Shalom Congregation** in Minnetonka, with **over 600 people** attending in person and virtually. The service included testimony shared by second generation Holocaust family member Cheryle Atkin as well as remarks by immediate past chair of HIAS, Robert Aronson. Additionally, Bet Shalom educator Ali King and student Gabby Ladmer reflected on their experiences visiting the US Holocaust Memorial Museum and the importance of Holocaust education and remembrance.



Leo Weiss Courage to Teach Award

In memory of Leo Weiss, *z*"*l*, the **Stesin family** and the JCRC annually honors an educator or institution that embodies decency, righteousness, and integrity in their devotion to teaching students about the Shoah. This year, Daniel Perucco, Edgewood Middle School teacher, was honored with the award. Perucco has taught English Language Arts for ten years and has brought Holocaust education speakers into his classrooms numerous times. He goes above and beyond for his students to make learning experiences that are meaningful and has also been awarded the Mounds View Education Association Community Educator Award.

Transfer of Memory and International Holocaust Remembrance Day

The Transfer of Memory exhibit, a collection of portraits and accompanying stories of Minnesota Holocaust survivors, provides a platform for communities to dive deeper into Holocaust education while understanding the personal stories of those who survived.

Sara Reininger, granddaughter and great granddaughter of survivors Eva Gross and Ella Weiss, *z*"*l*, spoke about her grandmother while Transfer of Memory was exhibited for an International Holocaust Remembrance Day program.



South Dakota Holocaust Education Symposium

The JCRC's Holocaust education program is honored to be part of the US Holocaust Memorial Museum's Community of Holocaust Education Centers. As part of this national cohort, we have a broader network in which to support, develop and distribute accurate and relevant resources for quality Holocaust education.

In August, Susie Greenberg, Director of Holocaust Education, went to Sioux Falls to facilitate an all-day Holocaust education professional development to South Dakota educators representing 11 school districts. Together with Scott Littky of Institute for Holocaust Education in Omaha, Sam Goldberg of HERC Milwaukee and Kristin Thompson of Humanus Network, the sessions ranged from Americans in the Holocaust to the power of Nazi propaganda.

History Day Competition

JCRC annually sponsors prizes in the Minnesota Historical Society's National History Day competition. Students choose to do a project on a topic relating to the Holocaust and the history of Europe between the years of 1939 and 1945. The prize winners of the 2024 theme, "Turning Points in History" were documentaries by Oak Grove Middle School in Bloomington on "The German Invasion of Poland," and Eden Prairie High School on "The Ritchie Boys: How a secret Allied Intelligence Unit Changed the Course of WWII."



Survivor and Descendant Testimony

JCRC supports Holocaust survivors and their descendants to keep their family testimony alive by connecting them with schools, community organizations, religious groups and other audiences. These speakers share their family's personal story of surviving the Holocaust and teach broader lessons about antisemitism and hate.

Manny Gabler, a Holocaust survivor who escaped Nazi occupation when he was a baby and found refuge with his family in Shanghai, spoke to 1,100 students at Benilde-St. Margaret's, a Catholic school in St. Louis Park.

Third generation Holocaust survivor family descendants are an important part of our Holocaust Education Speakers' Bureau. This group has an active and growing membership and recently became an affiliated member of the USC Shoah Foundation's Living Links, the first national organization in the U.S. dedicated to supporting grandchildren of Holocaust survivors in preserving and sharing their loved ones' experiences.

Campus Advocacy: Supporting Jewish Students, Faculty, and Staff

Reversing the hiring of anti-Zionist professor to lead U Holocaust center

JCRC's signature achievement of the 2023-24 academic year was organizing intense grassroots opposition to the University of Minnesota's decision to hire Prof. Raz Segal as Director of the **Center for Holocaust and Genocide Studies**. Atop this list of his many inflammatory and disqualifying statements was writing on Oct. 13, 2023, that Israel's nascent response to the October 7 massacre was "a textbook case of genocide." Five days after the hiring was reported by TC Jewfolk, JCRC welcomed Interim President Jeff Ettinger's announcement that the directorship search would start over.



Senate Hearing

JCRC was proud to participate in a MN State Senate Judiciary Committee hearing convened by **Senator Ron Latz** on the pattern of antisemitism at the University of Minnesota. This session brought to light the systemic anti-Israel toxicity at the University of Minnesota and emphasized the importance of moving forward together so that antisemitism has no place on campus.



Calling out pro-Hamas rhetoric by encampment organizers

As pro-Hamas rhetoric spread from the illegal encampment on the University of Minnesota campus mall, JCRC worked with Minnesota Hillel by:

- Organizing over **220 emails** to all **12 U Regents**;
- Calling out the U's appeasement of those normalizing anti-Jewish violence on campus;
- Challenging inaccurate media coverage portraying the encampment protests as "anti-war" or "pro-peace;" and
- Centering Jewish student testimony describing an increasingly hostile learning environment.



Jewish Identity, Israel, and Antisemitism Education

Teaching the Jewish story and shining a light on antisemitism in K-12 schools

We continue to partner with Jewish students, parents, educators, and school administrators in confronting antisemitism through our staff trainings on Jewish Identity and Antisemitism, carefully cultivated relationships, and our client-centered incident response advocacy. Our community is thoughtful and resilient. It is a privilege to partner with Jewish stakeholders as we work towards our shared goal of public and private schools in which Jewish identity is understood and honored.



JCRC Youth Fellowship for Jewish Identity and Leadership

JCRC launched a new youth fellowship to help our Jewish teens navigate the new post-October 7 reality while strengthening their Jewish identity and leadership skills. Meeting monthly over one academic year, this program empowers Jewish high school juniors and seniors to explore and embrace their history, develop leadership skills, and cultivate a deep sense of pride in their Jewish identity. Participants will learn how to articulate their own narratives and advocate for our resilient community.

There are **23 fellows** enrolled in the program; students who complete all program requirements will earn a \$1000 stipend, generously funded by an anonymous donor. By making several sessions open to all Jewish teens and by requiring Fellows to share something they have learned with their peers through a capstone project, we aim for a ripple effect across our community.

JCRC consulting for the Weitzman National Museum of American Jewish History



We are proud to be partnering with the Weitzman National Museum of American Jewish History to develop a national educational curriculum on American Jewish history for primary and secondary schools.


Jewish essayist and author **Dr. Dara Horn**, a consultant to the museum, recommended JCRC to Weitzman after visiting the Twin Cities. While here, she experienced our Judaism 101 presentation which projects a positive picture of Jewish life including our history, culture, and traditions as a 3,000-year-old people.

The Stan Shapiro Judaism and Israel Education Fund

The Stan Shapiro Judaism and Israel Education Fund was created to honor the life and legacy of Stan Shapiro, a WWII veteran, devoted family man, and a builder of both home, family and



community with unwavering integrity. His life was deeply rooted in his love for Israel and the Jewish people, and he held a profound belief in the value of "generation to generation." Stan, together with his beloved wife Sandi, whom he was married to for 54 years, instilled this passion in their children—Beth, Craig, and Steve—and grandchildren—Emily, Hannah, Jack, and Norah.

Stan frequently visited Israel, often bringing his family not only as tourists but as volunteers, passing down his love for the land and its people. A lifelong learner, he found joy in attending lectures and reading about Israel's history and current events.

To his grandchildren, Stan was a warm, loving, nonjudgmental presence with a big heart and an even bigger sense of humor. They have fond memories of him attending every birthday party, holiday dinner and sporting event and remember his wisdom: "At the end of the day, your family is the most important."

In memory of Stan's commitment to family and community, his family established this fund to support programs that foster Jewish identity, education, and a strong connection to Israel. Through this fund, Stan Shapiro's legacy lives on, impacting future generations with the same love, kindness, and pride that defined his life.
